#### WHO WE ARE and WHAT WE DO:

- ☐ The Partnership for Water Sustainability in BC is a not-for-profit society. We are volunteers.
- □ For the past decade, we have been responsible for delivering the **Water Sustainability Action Plan**:
  - Water sustainability in the local government setting will be achieved by implementing green infrastructure policies and practices. How we get there relies on a change in mind-set and "land ethic". Our role is to facilitate that change.
- □ As the "implementation arm" for the **Living Water Smart** and **Green Communities** initiatives:
  - Our areas of responsibility are community development and outreach
  - > We are developing decision support tools and local government talent.
- □ We are integrators. We play a bridging role between the Province, local government and community.

#### PURPOSE OF UPDATE PRESENTATION:

- □ Recognize Metro Vancouver as a "Champion Supporter" of the Partnership.
- □ Foreshadow how collaboration with Vancouver Island local governments will help Metro Vancouver members fulfil the "Minister of Environment's conditions" for protecting watershed health.

## **OUR HISTORY WITH THE COMMITTEE PROVIDES CONTEXT:**

September 14, 2011 – We asked for funding for Water Balance Model Express for Landowners.

**NOTE:** This web-based tool will help members fulfil your regulatory requirements pursuant to the Actions listed in the region's Integrated Liquid Waste and Resource Management Plan (ILWRMP).

A \$50,000 grant from Metro Vancouver leveraged ~\$250,000 in co-funding (i.e. cash + in-kind contributions).

■ May 9, 2012 – We introduced the benefits of the Inter-Regional Education Initiative (IREI) for 'Rainwater Management in a Watershed Sustainability Context'.

**NOTE:** A guiding principle is that IREI program elements will align with local government mandates, priorities and internal work plans. Through sharing, a program goal is to leverage more with the same resources.

To demonstrate how to make inter-regional collaboration tangible, the Partnership and four regional districts implemented a 'proof of approach' on Vancouver Island in 2012: they represent 90% of the Island population.

October 10, 2012 – We asked the Committee to formalize its support for inter-regional collaboration.

**NOTE:** The Committee passed the following resolution:

THAT the Utilities Committee refer to staff the request from delegate Kim Stephens to collaborate with the Partnership, as it relates to Strategy 3.2 of the Integrated Water Resource Management Plan and opportunities to inform municipal councils about the benefits of sharing and leveraging

#### MORE ABOUT THE INTER-REGIONAL EDUCATION INITIATIVE:

- ➤ The Water Balance Goal: After development or redevelopment, each site will function as it did before, or better!
- > To Protect Watershed Health: "Integrate the Site with the Watershed and the Stream"
- The emphasis is on the 'how-to' details of implementation and integration.
- Local governments learn from those who are leading by example.
- Collaboration is the pathway to an outcome-oriented approach to implementation and integration within and between regions.
- Everyone needs to agree on expectations and how all the players will work together, and after that each region and each community can reach its goals in its own way.
- > Collaboration will accelerate affordable and effective outcomes within each region.
- ☐ In Metro Vancouver, the spotlight is on a "course correction" in the way *Integrated Stormwater Management Plans* (i.e. "ISMPs") are developed because: the Minister's "conditions of approval" link land use planning and watershed health; and the Partnership has drawn attention to the benefits of a paradigm-shift to a "watershed/landscape-based approach" to community development:
  - From Output-Oriented ISMP: "What is the capacity of the conveyance system, and how much will it cost to make the pipes larger?"
  - > To Outcome-Oriented Watershed Blueprint: "What do we want this place to look like in 50 or 100 years, and how will we get there?"

NOTE: A Watershed Blueprint guides land use planning, views the watershed through an asset management lens, is action-oriented, sets achievable performance targets, provides planners with the level of detail they need to effectively review development applications, identifies opportunities to restore watershed function, and is implemented over decades.

- □ North Vancouver District's *Hastings Creek Watershed Blueprint* is provincially significant and precedent-setting because it:
  - > shows **how** local governments can implement the "ISMP Course Correction";
  - demonstrates what a "landscape-based" blueprint approach looks like in practice;
  - > illustrates the power of partnerships in leveraging more with the same resources;
  - > showcases the application of two web-based tools, namely: the *Drainage Infrastructure* Screening Tool; and the *Water Balance Model Express for Landowners*; and
  - > is informing and influencing how other jurisdictions are likely to apply lessons learned.
- ☐ In 2013, the Partnership is facilitating an inter-regional collaborative process that will bring together local government representatives from the Metro Vancouver region and four largest Vancouver Island regional districts, as well as representatives from two regional offices of the Ministry of Environment:
  - ➤ The theme is Watershed Health → how to measure it and how to monitor progress.
  - ➤ The concept is that each of the five regions will host a "sharing and learning" working session → what each is doing, what works and what does not.
  - ➤ The desired outcome is inter-regional consensus on a performance monitoring framework that can be used to adjust actions and inform land use planning that maintains healthy streams → a framework that is effective, affordable, adaptable AND involves the stewardship sector.

We value our long-term relationship with Metro Vancouver and are therefore pleased to inform the Regional Board that Metro Vancouver is hereby deemed to be a **Champion Supporter** of the Partnership for Water Sustainability in British Columbia.

The Champion Supporter designation recognizes both the historical and ongoing contributions of organizations such as Metro Vancouver, without which there would be no Partnership and no assets such as the Water Balance Model (WBM) decision support tool and waterbucket.ca website.

While the Partnership is a not-for-profit society, our voting members mostly represent local governments. Looking ahead, we anticipate that the Express and related "convening for action" collaborative initiatives will help the region and municipalities better deliver on regulatory compliance pursuant to actions specified in the *Integrated Liquid Waste & Resource Management Plan*.
